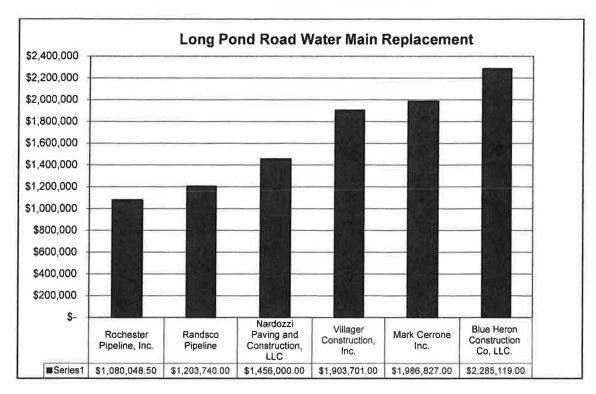

1. <u>Personnel Items</u> (Memorandums enclosed):

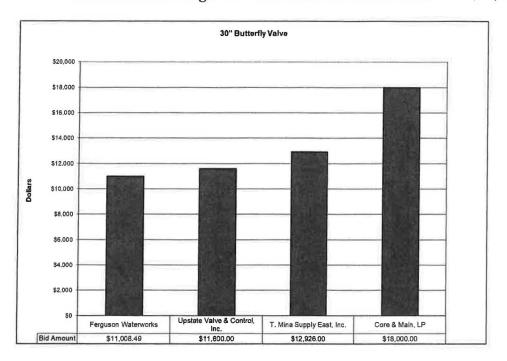
- Resolutions marking the retirements of Karin Anderson, David Hendershot, and Steven Sutera. We appreciate their many years of dedicated service to the Water Authority and wish each of them a happy and fulfilling retirement.
- Appointment of Anthony Marchetti to the title of Laborer in Facilities, Fleet and <u>Operations</u>. Mr. Marchetti has previously worked installing water services for new homes. His prior experience will make him a good fit for this position.
- Appointment of Michael Vinci to the title of Laborer in Facilities, Fleet and Operations. Mr. Vinci has recently worked at Monroe County Water Authority painting fire hydrants and would like to continue employment with MCWA. He has been a conscientious employee this summer and he will be a good fit for this position.
- Promotional appointment of Michael Salisbury to the title of Utility Worker in the Production/Transmission department. Mr. Salisbury has worked in the Operations department for thirteen years. He interviewed well for the position in the leak detection area and felt to be a good fit.
- Promotional appointment of Tracy Porter to the title of Office Clerk III in the Finance/Business Services department. Ms. Porter has worked approximately five years in customer service and has done a fine job. She is reachable on the eligible Civil Service list for the title.
- 2. There is an item on the Agenda to authorize the purchase of two (2) 42"concrete pipe adapters from Thompson Pipe Group.
- 3. There is an item on the Agenda to authorize the award of a unit price contract for ductile iron pipe from Core & Main.

- 4. There is an item on the Agenda to amend resolution #15-217 to reflect a change of New York State award and contract numbers for Wex Bank Fuel Card Services.
- 5. The is an item on the Agenda to authorize the use of Sourcewell Purchasing Cooperative for Verizon Connect GPS tracking system.
- 6. There is an item on the Agenda to authorize the use of New York State OGS contract for the purchase of Ultra Low Sulpur Diesel Fuel from Noco Energy Corporation.
- 7. There is an item on the Agenda to award a unit price contract for the Long Pond Road Water Main Replacement project in the Town of Greece. The project involves furnishing and installing approximately 2,280 linear feet of 8" and 3,400 linear feet of 12" ductile iron water main and appurtenances on Long Pond Road (County Road 136). There were six bids submitted. Our recommendation is to award this work to Rochester Pipeline, Inc. in the bid amount of \$1,080,048.50.



8. There is an item on the Agenda to approve payment to 1655 Elmwood Associates, LLC for granting permanent easements on four parcels at 1815 South Clinton Avenue. The four easements are needed to replace an existing water main with a high break frequency. Based on an appraisal of the property prepared for the Authority by Bruckner, Tillett, Rossi, Cahill & associates the total compensation for the permanent easements is \$31,975.02.

9. There is an item on the Agenda to award a contract to furnish and deliver a 30" butterfly valve. There were four bids submitted. Our recommendation is to award this contract to Ferguson Waterworks in the bid amount of \$11,008.49.
