1. REVIEW OF DEFERRED COMPENSATION AUDIT

Mr. Douglas Zimmerman of EFPR Group provided the Committee an overview of the audited financial statements as of December 31, 2020 for the Deferred Compensation Plan for Employees of the Monroe County Water Authority. He stated it was a "clean audit" and no management letter was issued. Following the review and some discussion, the Audit Committee proceeded as follows:

Ms. Molinari stated she anticipates the name of the bank selected to perform these services will appear on the August 2021 Board meeting agenda. This was for informational purposes only; no formal action was taken.
