**INSPECTION: 30 minutes prior to sale.**

**COST: There is a reserve price on each item.**

**PAYMENT: \$10,000 U.S. certified funds by end of business day of auction, balance due in two days.**

**SALES: ALL SALES ARE FINAL. NO refunds. NO returns. NO exchanges. NO turndowns.**

1. MCWA reserves the right to add or withdraw any item(s) before the sale.
2. The MCWA representative has the right to suspend or terminate bidding privileges from customers immediately due to the following actions: intimidating language or verbal threats, physical altercations, intentionally altering the condition of auction items for the purpose of suppressing the sale price, collusion with the intent to restrict competition, stealing or destruction of property.
3. All goods have been available for inspection and are being sold on an “as is” and “where is” basis with no guarantee expressed or implied by MCWA. Buyers are encouraged to inspect all items before bidding.
4. Sale will be made to the highest bidder, subject to the following terms of sale; however, if there is a disputed or tied bid among two or more bidders, the MCWA Representative, at their discretion may determine the highest bidder or the bidding may be re-opened to determine the highest bidder. In any case, the MCWA Representative’s decision will be absolute.
5. MCWA Representative reserves the right to reject any and all bids.
6. Full payment must be made within two business days of the completion of the auction in U.S. certified funds ONLY. A bill of sale will be furnished once payment has been made.
7. All bidders must be 18 years of age or older.
8. Buyer agrees to pay any and all applicable sales tax upon registration.
9. Loading services are not provided by MCWA. The winning bidder is responsible for the loading and removal of purchased items and assumes all risk incidental to such loading and removal. The winning bidder is responsible for any damage and/or personal injury caused by removal of items. This includes the obligation to repair and restore any damage to the property to the satisfaction of the facility representative. Removal must be made during MCWA business hours within four business days of the auction. A copy of the bill of sale must be furnished at the time of removal. Failure to comply with the removal terms may affect future bidding privileges. Items not removed will be forfeited and the buyer will have no recourse. The use of MCWA seals or insignias on private vehicles is prohibited.
10. By bidding, you acknowledge acceptance of these terms and conditions whether present during the actual auction or not.
11. All bids shall be arrived at independently without collusion, consultation, intimidation, communication, or agreement, for the purpose of restricting competition, with any other potential bidder.
12. Registration MUST match Bill of Sale. The Bill of Sale will be issued in the bidder’s name.
13. NOTICE: It is expected that all buyers shall responsibly use this property including its disposition in conformance with applicable laws, rule and environmentally preferred practices.
