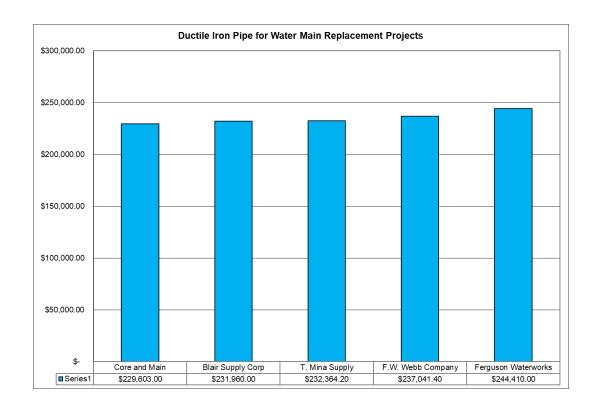

AGENDA ITEMS:

1. Personnel Items

- There are items on the Agenda marking the retirements of James Clark, Liliana Dos Reis, and Bruce Green. We appreciate their many years of dedicated service to the Authority and wish them happy and fulfilling retirements.
- Appointment in our Facilities, Fleet and Operations Department for Jeremy Aponte to the title of Skilled Laborer at an hourly rate of \$20.46. This appointment is to fill a current vacancy. The applicant interviewed favorably and was found to be well-suited for the position. See enclosed memorandum from Steve Trotta.
- 2. There is an item on the agenda to authorize the purchase of services and materials to repair medium voltage variable frequency drive (VFD) units for one pump located at the Lake Water Pump Station and one high duty pump located at the Webster Water Treatment Plant. A field technician from the equipment manufacturer, ABB, Inc., will perform the repairs. The VFDs and associated pumps are currently out of service until the repairs are completed.
- 3. There is an item on the agenda to award a contract for the purchase of approximately 4,720 LF of 8-inch and 220 LF of 12-inch zinc coated class 52 ductile iron pipe. The pipe will be used in upcoming water main replacement projects. Five bids were submitted. Our recommendation is to award this contract to the low responsive, responsible bidder, Core and Main, Inc. in the bid amount of \$229,603.



- 4. There is an item on the agenda to authorize an Agreement with the Village of Brockport for the transfer of 17 Village of Brockport residential customers (122 to 232 East Avenue) to Monroe County Water Authority (Authority). There are currently two water mains along East Avenue, which is also the Town of Clarkson and Village of Brockport line. The Village of Brockport has experienced failures on their main in this location and has requested the Authority transfer water services for these customers to the Authority's main in this location, which will allow the Village to abandon their main. The service transfers will be completed by an Authority contractor. The Village will reimburse the Authority for all expenses associated with the service transfers. The Authority will be able to provide the same level of service to these customers at approximately the same annual cost.
- 5. There is an item on the agenda authorizing an agreement with NYSDOT for their Intersection Safety Improvements at I-390 and NY-383 (Scottsville Road) in the Town of Chili. The Agreement with NYSDOT will allow their contractor to make adjustments to water system facilities as necessary to accommodate the work associated with their project. NYSDOT's work will be completed at no cost to the Water Authority.

- 6. There is an item on the agenda to authorize the award of a Professional Services Agreement to five firms to provide IT Staffing services for an estimated annual amount of \$250,000. See enclosed memorandum from Justin Moore.
- 7. There is an item on the agenda to authorize the execution of a contract with the New York State Department of Health (the "NYSDOH") to receive a grant in the amount of \$47,500 under the NYSDOH Drinking Water Fluoridation 2021 Round 4 Component 1 (Planning and Feasibility) Projects program. Non-competitive Contract No. DOH01-T37942GG-3450000 will provide grant funds to hire a professional engineering consultant to assess existing fluoride storage and feed systems located at the Shoremont and Webster Water Treatment Plants and evaluate alternatives for improvements. The consultant will prepare an Engineering Report presenting the results of the evaluation; recommendations and a basis of design for improvements to ensure long-term operational reliability; and estimated cost and schedule for construction. The consultant will also prepare final design of the recommended improvements; prepare bid documents and provide bidding assistance; and provide construction phase services for implementation.
- 8. The Authority's Standard Procurement Compliance Resolution.

Information Technology is requesting authorization to award the IT Staffing Services RFP/Q to the five different vendors. The five highest scored vendors are Avani Technology Solutions, Entre Computer Services, V3IT Consulting, Cogent InfoTech, and MoxieIT Solutions. These are fully burdened hourly rate contracts for temporary on-site IT staffing with the option to directly hire. Furthermore, the contracts will be for a term of one year from March 1, 2023 to February 29, 2024 with four optional one-year renewals at an estimated aggregated annual total cost of \$250,000.

We received forty-seven proposals from prospective vendors for this solicitation. Proposals were evaluated and scored on overall pricing, availability for timely onsite support, qualifications of personnel, and references. Each member of the Selection Committee individually scored the proposals and those weighted total scores were averaged to rank each proposal. The top five ranked vendors are being nominated for contract awards. Lastly, by awarding contracts to five different vendors, the Authority will benefit by having more options to source from when IT staffing needs arise.
